ATB WITH SHOTGUN ENGAGE TWO KNOCKDOWNS AND STATIONARY IN THIS ORDER (S-KD-S-KD). STAGE SHOTGUN NEXT TO RIFLE AND RETRIEVE RIFLE AND ENGAGE RIFLE TARGETS IN THIS ORDER (2-1-1-1-1-2-3-3-3-3) THEN RESTAGE RIFLE AS BEFORE. MOVE INTO THE CELL (DOOR STARTS AND STAYS OPEN) AND WITH PISTOLS ENGAGE PISTOL TARGETS IN THIS ORDER (2-1-1-1-1-2-3-3-3-3) WITH MUZZLE THRU THE BARS AND RE-HOLSTER. (SHOTGUN, RIFLE, PISTOL, PISTOL)
